The Prinergy Cloud File Archive and Backup service is an intelligent, automated file storage solution for users of Prinergy Workflow.

Prinergy Cloud: File Archive and Analytics Service – Authorized Features:

- File Storage (amount) based on the tier level indicated on the sales contract
- 1 Prinergy Cloud Decision Analytics dashboard
 - To view storage account activity
 - To view Prinergy Workflow system usage activity

Prinergy Cloud: File Archive and Analytics Service - Deliverables:

Kodak will remotely activate Your account and install the following software components on Your **Prinergy** Workflow system to enable the service:

- Prinergy Cloud agent software
- Prinergy Cloud activation files
- Prinergy Workflow system RBA Read Only license and rule set

Prinergy Cloud: File Archive and Analytics Service – Users and Access by Users:

Your use of the service is limited to persons authorized by You. This consists of two main groupings of persons: Prinergy Workflow operators and Decision Analytics dashboard users.

The Prinergy Workflow operator group consists of Your personnel who have authorization to log into and use the Prinergy Workshop software application.

The Decision Analytics dashboard user group consist of named users, that You have granted access to view and download production information from a Decision Analytics dashboard.

Prinergy Cloud: File Archive and Analytics Service - Service Cancellation:

Cancelling a service subscription is transacted via a signed sales order, that will authorize Kodak to delete all remaining data that is stored within Your account, 30 days after the order is booked.

You will also receive 1 final invoice for the 30-day data retention period. Upon cancelling Your service subscription, you will be given the option to:

- Terminate the service by the cancelation date and forfeit access to the service immediately. All files and data associated with your account will be disposed by Kodak immediately and not available any more
- Purchase additional time to retrieve Your files in 30 day allotments up to a maximum of 90 days

Both options result in all data including meta-data collected during Your subscription period to be deleted at the time the subscription cancellation becomes effective.

- Purchase additional storage space from Kodak, if You exceed the subscribed tier as defined on the sales order, for 2 consecutive months.
